Hello.

Under the California Public Records Act, Government Code sections 6250-6270 (as well as the California State Constitution), I hereby request all policy documents and internal/external memorandums, as well as written or otherwise documented justifications, regarding why many VPN protocols (in particular OpenVPN, WireGuard, IPsec/L2TP, and SSH) are blocked on District networks.

I seek this information for the benefit of the public, to be able to better understand District policy and procedure, and to provide necessary information to potentially challenge policies in the future.

Under the CPRA, a response to this request must be returned within 10 days (not business or instructional); thus, please respond by no later than 11:59:59 PM Pacific Time on February 2, 2023. Earlier would be preferable if possible; however, the time listed is the absolute latest a response can be received while still abiding by state law.

You can also contact me by SMS or RCS at (562) 299-8551; please understand that calls to this phone number may not go through and should not be considered a reliable means of communication.

It would be preferred if documents could be provided digitally. However, if some documents are only available for physical viewing, please let me know and I will work to find a time for physical inspection under GOV sec. 6253(a-c). Please note that I will not accept physical replications by the District for which I am charged; if these are provided free of charge, they are acceptable. Otherwise, I will scan the documents myself.

6253(d): "Nothing in this chapter shall be construed to permit a public agency to delay or obstruct the inspection or copying of public records.
