**reports, studies, public comments, and surveys held/received by the District from between October 1, 2018, and September 30, 2023, regarding the issue of homework assignments (such as whether to assign homework, how much homework to assign, etc), not otherwise exempt from disclosure.**

I request the documents in electronic format; if the documents are only in physical format, I request that they be scanned at no cost. If a cost is required, I will exert my right to scan the documents using my own equipment and to view them in person pursuant to GOV 7922.525.

If any documents are nondisclosable, those documents should be segregated, and the disclosable documents provided. If content on/materials in the documents are nondisclosable, those should be redacted pursuant to GOV 7922.525(b).

If any segregations are performed, or this request is denied in its entirety, please note that under GOV 7922.540, the names of all individuals involved in the denial of the record must be provided.
