I'm writing to clarify how the response time works for Public Records Requests in local government pursuant to the Code of Civil Procedure (CCP §10, et seq. but more specifically, §12a, subdivision a-b). When a government agency is closed for any reason, requests are considered received on the next business day. This is why my staff informed you that the receipt date was Monday, Oct. 16 since your email was sent on Friday, Oct. 13 when City Hall was closed. As such, a response (not necessarily the records), which is what the Public Records Act (PRA) stipulates, will be provided to you by the 10th day. That date is Oct. 26.

For future reference, when seeking records from the City of Norwalk, requests should be directed to the City Clerk's Department, which will prevent potential delays if sent elsewhere. Also, in response to your request for a single table, the PRA does not require local governments to create records, so if the data you seek is in a form other than a single table, it will be presented as it is maintained.

Staff will attempt to locate the records you seek prior to Oct. 26 and have them available for you, but either way, a response will be provided by that date.

I hereby request, under Division 10 (commencing with Section 7920.000) of Title 1 of the Government Code (also known as the "California Public Records Act"), copies of all reports and information from January 1, 2021, to June 30, 2023, regarding delays and cancellations on Norwalk Transit System bus routes, not otherwise exempt from disclosure. A single table of rates of delays and cancellations per line would satisfy this request, but if an existing record does not exist fitting that requirement, a record with substantially the same/similar information would suffice.

I am requesting electronic copies of these documents, and as such, no fees should apply; if any documents need to be scanned, please alert me, and I may exert my right to scan the documents myself.

If any documents are nondisclosable, those documents should be segregated, and the disclosable documents provided. If content on/materials in the documents are nondisclosable, those should be redacted pursuant to GOV 7922.525(b).

If you have any questions about this request, you can contact me at this email address, or at (562) 299-8551 by SMS or RCS (phone calls may not always be returnable).

If any segregations are performed, or this request is denied in its entirety, please note that under GOV 7922.540, the names of all individuals involved in the denial of the record must be provided.

Under GOV 7922.535(a), the records must be provided within ten calendar days; as such, please provide the records by no later than October 23, 2023 (with intentional delays to or beyond that point prohibited by GOV 7922.500).
