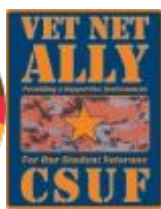

I request the documents in electronic format; if the documents are only in physical format, I request that they be scanned at no cost. If a cost is required, I will exert my right to scan the documents using my own equipment and to view them in person pursuant to GOV 7922.525.

If any documents are nondisclosable, those documents should be segregated, and the disclosable documents provided. If content on/materials in the documents are nondisclosable, those should be redacted pursuant to GOV 7922.525(b).

If any segregations are performed, or this request is denied in its entirety, please note that under GOV 7922.540, the names of *all* individuals involved in the denial of the record must be provided.

Under GOV 7922.535(a), the records must be provided within ten calendar days; as such, please provide the records by no later than October 22, 2023 (with intentional delays to or beyond that point prohibited by GOV 7922.500).
