Hello, Amy,

Thank you so much for meeting with me via phone on October 26, 2023 to discuss the scope of this PRA request. Our division had multiple projects which included public comment that we needed to search using keywords responsive to your request “regarding the issue of homework assignments (such as whether to assign homework, how much homework to assign, etc)”.

We searched public comment and the full documents for the following projects. Any public comment we found in our searches have been uploaded to a [box.com folder](#), separated out by project. We’ve added a few notes below based on searches of the publicly available guidance document itself below.

Page 27 offers guidance on creation of a virtual help desk for homework and technology assistance.

Public Comment in Box. The Model Curriculum mentions homework assignments as one of several different ways of promoting student engagement on page 46. There are various references to different kinds of homework activities throughout chapter 4 (sample lessons).

[Mathematics Curriculum Framework](#)

Public Comment in Box. The Mathematics Framework includes discussions related to homework in chapters 2, 9, 12, and 13.

Also, the May 2021 Instructional Quality Commission attachment "[Summary Table of Public Input on the Draft Mathematics Framework](#)" includes public comments from the first field review online survey that reference homework.

[Arts Education Curriculum Framework](#)

No public comment responsive to the request. There are two mentions of homework on page 716 of this framework.

[World Languages Curriculum Framework](#)

No public comment responsive to the request. There are 17 mentions of homework in chapters 2, 7 and 13 of this framework.

[Health Education Curriculum Framework](#)

No public comment ~~in Box. responsive to the request.~~ There is one mention of homework in chapter 2, however it is not a reference to student homework.

[Computer Science Standards](#)

No public comment responsive to the request.

The [Grading Student Progress](#) webpage references a study that recommends using other criteria besides homework for determining grades. And specifically mentions homework one time.

Hello,

I would be willing to meet to more strictly define the request. However, I would likely not change the time range (unless the number of records is too voluminous for my side to process), as denying a request because of the time range being too broad is not permitted under the CPRA.

Your response cited *Fredericks v. Superior Court*; however, you did not provide a clear showing that the request was unduly burdensome. Documents could be searched for using keywords like "homework", for instance, then further narrowed. We can discuss these narrowings during the meeting. Further, *Fredericks* provides the primary remedy for an "undue burden":

- Where an agency can show objectively that there is an undue burden in complying with a request, the CPRA provides for an extension of time. Under section 6253, subdivision (c), an agency's obligation to disclose in a timely manner may be changed by the circumstances of the case, if disclosable records are sought but specified "unusual circumstances" apply to them.
