We received your October 28, 2023 Public Records Act request for the following records:

I hereby request, under Division 10 (commencing with Section 7920.000) of Title 1 of the Government Code (also known as the "California Public Records Act"), copies of **the recording of the HSS event "The Israeli-Palestinian Conflict: Perspectives from HSS Scholars" on October 23, 2023.**

CSUF has conducted a reasonable search for these records under California

Government Code §7922.535 and has determined that your request, either in whole or in part, seeks copies of disclosable public records. CSUF has determined that the following exemptions apply to this request:

- Records containing intellectual property. Cal. Govt. Code §7927.705; Cal. Civil Code §3426, et seq.
- Records where the public interest against disclosure outweighs the public interest in disclosure. Cal. Govt. Code §7922.000.

Nevertheless, we will make the video available for you to view. This determination does not represent a waiver of the CSU's intellectual property rights in the video. CSU asserts its right to protect its intellectual property at all times.

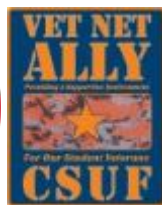
