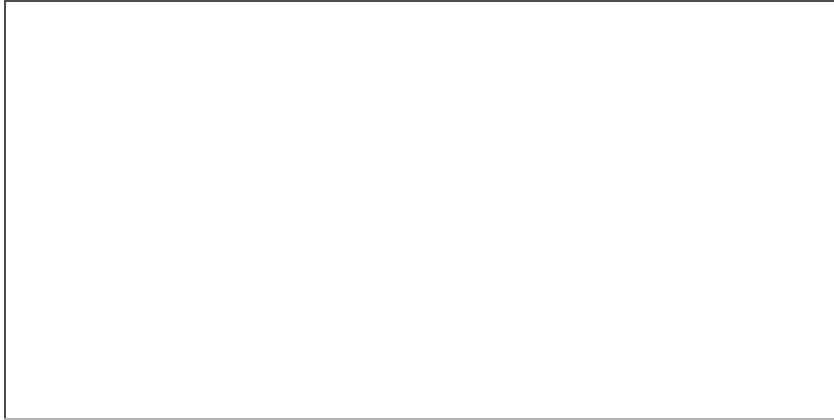
Hi Amy,

I'm happy to help with this request. So that I can appropriately query your request, can you please provide me with a date range for the communications you seek? Once you provide a date range, I'll enter the query and let you know whether we believe we have responsive documents.

As you may know, the PRA does not require public agencies to make disclosable documents available within a certain time frame. Rather, the PRA requires public agencies to determine, within ten days of receipt of the request, whether the requestor seeks copies of disclosable public records in the agency's possession. Please be aware that we are currently

experiencing an unusually high number of public record requests. We will continue to process all requests in the order they are received. As such, processing may take longer than usual.
