We are following up with you regarding your public records request submitted to this agency. Your request is attached.

Based on the breadth of the specific request, this office has identified 616 pages that may be responsive. These records may include documents containing information that is confidential and exempt from section 119.07(1), Florida Statutes, and section 24(a), article I of the Florida Constitution. For example, materials that were prepared by an agency attorney or prepared at the attorney's direction that reflect mental impressions, conclusions, litigation strategy, or legal theories of the attorney or agency prepared in anticipation of litigation

are exempt from production pursuant to section 119.071(1)(d), Florida Statutes.

Consequently, your specific requests will require an extensive use of agency personnel and time, as well as information technology resources, to retrieve and review the documents responsive to your request and ensure compliance with the exemptions under section 119.071, Florida Statutes, and applicable law. Therefore, an initial labor deposit is being assessed pursuant to section 119.07(4)(d), Florida Statutes for 50 percent of the total cost estimate, at an initial labor deposit of **\$75.70**. Please note that we estimate these requests may require multiple hours or more of review at appropriate hourly rates. The actual hourly rate of the lowest hourly rate of the employee capable of performing the work needed to comply with these public records requests will be assessed against the initial labor charge.

Pursuant to Florida Public Records Act, section 119.07(4), Florida Statutes, please provide us with a check in the total amount of **\$75.70** made payable to Executive Office of the Governor and sent to my attention at 400 S Monroe Street, Suite 209, Tallahassee, FL 32399.

Upon receipt of the aforementioned check, this office will begin to review responsive records. Once the responsive records have been reviewed, this office will send you an additional invoice for the remainder of the cost required to produce the documents. Upon receipt of payment in full, we will forward to you the documents responsive to your request. Due to the scope of your public records request, we estimate that the production of these records will take an extensive amount of time to complete.

Please note that if this office does not receive a response within thirty (30) days from the date of this letter, we will close out your specific requests as non-responsive. Please do not hesitate to contact this office in the event that you would like to discuss your current request, or if you would like to narrow it in any fashion.

Under the Florida Sunshine Law (Chapter 119 and other relevant statutes of the State of Florida), I hereby request **all emails from official email addresses of the Governor, Lieutenant Governor, and Attorney General, to the extent that they are not exempt under the statutes of the State of Florida (with exempt content redacted), which contain the keywords "gay", "transgender", "lesbian", "bi", "bisexual", "Don't Say Gay", "HB 1557", "H.B. 1557", "LGBTQ+", "LGBTQ", "LGBTQIA+", "LGBT", "LGB", "parent rights", "parental rights", or "indoctrination", from October 1, 2021, to September 30, 2023.** These emails are requested in electronic format.

This request is intended on behalf of the public to provide the residents of the State of

Florida with greater access to information and communications between their public representatives; to that extent, we request a waiver of any search fees, especially given the trivial nature of the request. If any fees must be charged, do not continue with the request until fees have been paid.

Any delays beyond those necessary for the actual retrieval of the document are in violation of Florida law, per *Tribune Company v. Cannella*, 48 So. 2D 1075, 1078 (Fla. 1984). Furthermore, computerized public records are governed under the same rules as paper documents, as stated in *Siegle v. Barry*, 422 So. 2D 63, 65 (Fla. 4th DCA 1982).

This request includes every person who has custody of the requested documents as stated in Florida st. sec. 119.07(1)(a). This request also extends to memos sent interoffice and intra-office from one public employee to another in relation to the documents requested, as stated in *Shevin v. Byron, Harless, Schaffer, Reid and Associates, Inc.*, 379 So. 2D 633 (Fla 1980).

If portions of the requested records are closed or exempt, please segregate the closed/exempt portions and provide the rest.
